- **Charitable Giving:** Supporting organizations and causes that promote social well-being, address pressing needs, and foster sustainable development

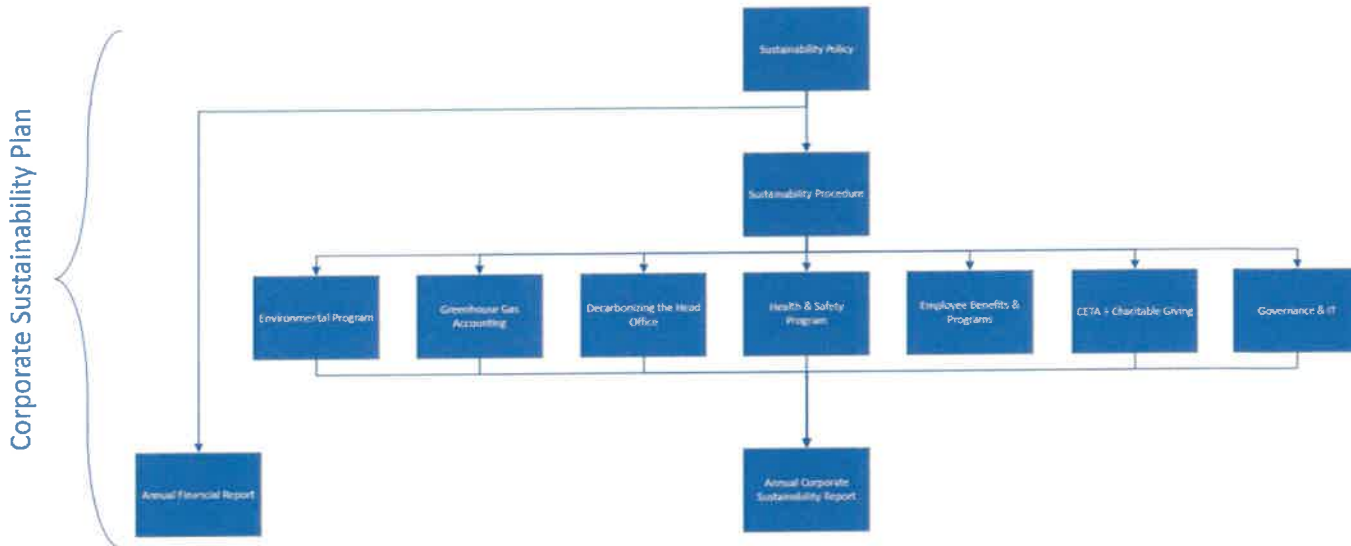
GOVERNANCE
